Roanoke County Launches New Campaign Against Littering

From cigarette butts at local intersections to discarded trash strewn along Roanoke County's roads, litter continues to be an issue for our community. To raise awareness about this problem, Cave Spring Supervisor Charlotte Moore has led a new initiative to help combat littering in Roanoke County.

Beginning in January, drivers will see temporary road signs at major County intersections reminding everyone that "The World Is Not Your Ashtray," a clear reference to the growing number of cigarette butts appearing at intersections and road medians.

Along with the intersection signs, this new program will feature a local partnership with Lamar Advertising for billboard space and also include signage on County vehicles, including the County's fleet of trash collection trucks.

"Supervisor Moore's campaign against discarded cigarette butts is a great starting point for this program," Assistant County Administrator Richard Caywood said. "It's a visible problem that thousands of County motorists see every day. Our hope is that by raising awareness of this first issue, we can open everyone's eyes to the larger problem of litter in the County. We plan on bringing additional ideas to the Board of Supervisors in the future."

To support the launch of this new anti-littering campaign, Cave Spring Supervisor Moore and Virginia Senator Ralph Smith hosted local media at the Roanoke County Administration Center on Friday. Moore and Smith made remarks about the new efforts, highlighting the importance of working together to keep our community beautiful.

Roanoke County has also launched an online form citizens can use to report littering. This convenient web form will send littering complaints directly to Roanoke County Police for follow-up. Website visitors are encouraged to look for the Report Littering button on the County's home page or see www.roanokecountyva.gov/litter.

Gum Springs Road Construction Project Complete

Virginia Department of Transportation (VDOT) has completed work to construct a cul-de-sac at the end of Route 714, Gum Springs Road, in Roanoke County. Gum Springs Road is a dead-end road which, until recently, did not have an adequate turn-around area at the end. This project allows school buses, trash trucks, fire engines and other large vehicles to turn around without using neighbors' driveways.

The project was funded through the VDOT Revenue Sharing Program; a matching funds program where VDOT and Roanoke County share the costs of the project. Roanoke County engineering staff assisted with citizen contact, and plats for right-of-way donation. The Western Virginia Water Authority relocated two residential water meters, and made other adjustments to a water line under the cul-de-sac. VDOT administered the construction.



A Citizen Information Meeting (CIM) was held on January 30, 2014, at Country Inn & Suites on Plantation Road to receive comments on the conceptual layout for the [Plantation Road Bicycle, Pedestrian and Streetscape Improvement Project](#). Over 100 people attended to review the renderings and concept plan for the project and to speak with County staff, the consultants from [Whitman, Requardt & Associates](#) and [Land Planning & Design Associates](#) as well as VDOT staff. All of the materials from the meeting are available [online](#) including a [Comment Sheet](#) that can be completed and mailed back to Roanoke County by February 13th.

The project will now begin a detailed design phase using comments from the CIM. A Design Public Hearing on the 90 percent plans will be held in May.

What is Debris?

Are you concerned about junk or debris on private property in your community? Is it considered trash under Roanoke County Code? Per Section 13-154 of the [Code of the County of Roanoke](#), it shall be unlawful for the owner of any parcel to allow the accumulation of trash on any parcel or property. The owner of any parcel or property shall maintain all exterior property areas in a clean, safe condition free from the accumulation of trash. Any owner who violates this provision shall be subject to a civil penalty, which may be increased for subsequent violations within a twelve (12) month period.



Trash is defined as "abandoned personal property, garbage, refuse, rubbish, litter or debris."

Please report your concern through our [Code Compliance Complaint Form](#) accessed from the [Roanoke County Planning and Zoning webpage](#). Be sure to include the specific location of the alleged violation, a detailed description of your complaint and your contact information. A Code Enforcement Officer may need to contact you for additional information.

What Makes a Pothole?

Potholes are created when moisture seeps into the pavement, freezes, expands and then thaws.



This weakens the pavement. Traffic loosens it even more, and it eventually crumbles and pops out.

Save Money with a Home Energy Audit

Working with a professional auditor and respected contractor can be one of the best ways to save energy at your home and increase your home's value. Undertaking an energy retrofit can not only seal up nearly-invisible holes in your home that are letting energy - and money - escape, doing so can make your home healthier, more secure, and can serve as preventative maintenance to prolong its life. Such retrofits can be one of the best long-term investments you can make in your home.

However, a poorly performed audit or shoddy retrofit can end up costing you even more. Investing in energy conservation measures only make sense if you are sure you will save money, which means you need to trust your auditor's analysis and recommendations, and your contractor's skill. A knowledgeable team can find hidden

leaks in your home, recommend upgrades to appliances and HVAC systems, and provide calculations on cost savings and payback periods to help you make informed decisions on home improvements. An unqualified auditor or contractor, however, can not only overstate potential energy savings, but can make recommendations that do more harm than good. It's important to verify the qualifications of your auditing firm or contractor before getting any work done on your home. Below are a few tips for ferreting out potential scams:

- Be wary of auditors or contractors that promise miraculous-sounding energy savings. According to the Intergovernmental Panel on Climate Change (IPCC), most houses built before 1940 can expect 25%-35% savings from an energy retrofit, while houses built in the 90s and after can expect to see 12%. Auditors or contractors that promise to cut your bills in half immediately may be overstating their claims.
- If possible, work with an organization that can refer contractors. Save-a-Ton's list of auditor partners is a good place to start.
- Make sure you use a certified auditor with proof of certification - either BPI or RESNET preferably.
- If the firm claims to use BPI-certified workers, ask for names and BPI numbers. You can verify BPI certification by contacting Lynn Griffith, Manager of Certifications, at BPI.org. This Department of Mines, Minerals and Energy website also contains a list of BPI-certified professionals in Virginal.
- An auditor should be able to document experience if asked. And the consumer should ask.
- Assessment costs are variable, but generally average between \$300 and \$500. Be wary of assessments much outside of this price range.
- If the auditor shows up with nothing but a clip board do not let them in your house. A professional audit based on approved best practice involves sophisticated diagnostic testing and at a minimum will involve a blower door, infrared scanner/camera, heating system safety and combustion safety testing equipment, and a duct blaster.
- An audit cannot be done in a short amount of time. Length of the audit will vary but will require, in general, at least 2 hours.

A home energy audit is an important next step to maximizing your home's performance and reducing your energy bill. But remember - there are a ton of simple, DIY things you can do around the house to start knocking your power bill back almost instantly. March 4th

Four new applications submitted for the April 1st meeting were reviewed and the Planning Commission heard a presentation on the new GIS (mapping) website which will debut in late April.

March 18th

Roanoke County has launched a new generation of public geographic information system (GIS) applications that allow greater and easier access to the County's mapping, tax parcel, zoning, and government services data.

The new applications can be found in the new Maps & Apps Gallery through the [County's GIS page](#). The gallery includes several single-focused applications for the most popular day-to-day uses, real estate parcel and tax information, government services, and voter information.

A separate desktop computer application leverages new technology to provide citizens with three dimensional imagery of the County. Several of the applications feature a distinctive new "Property Report" feature that combines parcel data, three dimensional views, and map data all in one convenient report, much like the popular website [Zillow](#).

Professional and power users of Roanoke County's GIS data will be able to access advanced tools with the new OneView application also found in the [Maps & Apps Gallery](#).



May is National Asthma Month

May is National Asthma Month, and though you may hear a lot about air quality in the Roanoke Valley over the course of the month you may not know that the air quality in your home can be just as important as the air quality outside. A lot of factors can contribute to your indoor air quality, but fortunately there are some things you can do that will both freshen the air inside your home as well as reduce your energy bill.



One of the most important things you can do is regularly check and clean the filters protecting the intake of your air conditioner. A dirty filter can cause your system to work harder, using up more electricity than it needs to move and cool the air in your home, but it also means that dust and allergens that would have otherwise been caught by the filter are left floating in your home. Allergy attacks can be triggers for asthma attacks, so taking this simple step can help reduce instances of both.

When undertaking DIY energy efficiency projects it can be tempting to seal your home up tight, but beware: houses are meant to breathe a little, to let dirty air inside escape and bring fresh air in. This is especially important if you have natural gas appliances or other combustion equipment. Tightening up your home too much can trap dust and allergens inside, triggering asthma attacks and a wide array of other breathing problems.

Make sure there is sufficient venting around combustion equipment, and consider working with a professional auditor. Both you, and your home, can breathe easier this Asthma Month, and the money you'll save on your electric bill won't hurt either.

Over time, dirt and other deposits can build in your ductwork - including molds and mildews that are known to exacerbate asthma. Regular maintenance and cleaning of your HVAC system will not only mean your equipment is running at its most efficient, clean ductwork will keep the air moving through it cleaner, further reducing the strain on your system. In older homes where your equipment might be stored in a damp basement, regular maintenance and cleaning of your ducts can be doubly important to avoid the growth of mold.

How Tall is Your Grass?

Grass is growing very well right now with all of the rain that's been falling!

Remember that any plant, grass or other vegetation covering a substantial portion of a parcel zoned for residential, business, commercial or industrial use must be kept shorter than 12 inches tall.

Roanoke River Blueway Under Development

The [Roanoke Valley-Alleghany Regional Commission](#) is

working with a stakeholder committee composed of local governments, non-profits, paddlers, fishermen, local outfitters and watershed groups to develop the [Roanoke River Blueway](#), a 45-mile water trail on the upper Roanoke River. A blueway (also known as a water trail, paddle trail, or float trail) is a navigable waterway with sufficient capacity (flow, depth, and width) for successful progress of canoes, kayaks and other non-motorized vessels, with sufficient access and amenities to facilitate other recreational uses of the waterway. The Roanoke River Blueway flows through or borders the Cities of [Roanoke](#) and [Salem](#), the Counties of [Montgomery](#), [Roanoke](#), [Bedford](#), and [Franklin](#), and the [Town of Vinton](#), providing river access for canoeing, kayaking, fishing, tubing, wading, wildlife viewing, and other recreational opportunities. The Blueway also connects to numerous local parks; [Roanoke River Greenway](#), [Tinker Creek Greenway](#) and [Mill Mountain Greenway](#); [Blue Ridge Parkway](#); [Explore Park](#); [Smith Mountain Lake](#); and businesses proximate to the river.

The overall goal of the Roanoke River Blueway project is to facilitate and encourage recreational use of the Upper Roanoke River and tributaries by residents and visitors. Additionally, the project seeks to encourage watershed awareness and sustainable stewardship of the region's water resources. To date, the Roanoke River Blueway stakeholder group has developed a [Roanoke River Blueway website](#), interactive and printable maps, brochure, and other information to facilitate the safe and enjoyable use of the blueway including river access descriptions, hazards and portages, recommended minimum and maximum streamflow levels, contact information, and links to useful websites.

Moving forward, the [Regional Commission](#), local governments, and the Roanoke River Blueway stakeholder group will work to improve and promote the Roanoke River Blueway; seek grant funding and other financial support; work with local outfitters, businesses, and other entities to promote the blueway and increase river related recreation and tourism; and increase watershed awareness.

Commercial Vehicle Parking

Parking a commercial vehicle in a residential zoning district (R-1, R-2, R-3 and R-4) is prohibited. Such a vehicle is a truck or commercial vehicle with, or designed to have, more than two (2) rear wheels, except for pickup body type trucks or vehicles essential for an agricultural use associated with the premises. Commercial vehicles must be parked and stored elsewhere.

Watch for Air Quality Action Days this Summer

We're full into ozone season here in the Roanoke Valley - that time of year where the heat of summer can combine with other pollutants to cause ground-level ozone pollution, otherwise known as smog. Roanoke's topography means that pollutants

that might otherwise have been swept out of the valley can be contained here, leading to air quality challenges that can cause or exacerbate health problems for our citizens. Fortunately, the region has been steadily improving in air quality over the last ten years, meaning air quality action day alerts are few and far between.

If you're not familiar with air quality action day alerts, here's how they work: The [Virginia Department of Environmental Quality](#) monitors air quality at several points within the valley. Using this data and combining it with weather forecasts, DEQ will send out alerts for days where air quality is expected to be particularly poor. In Roanoke, this generally means a "Code Yellow" or "Code Orange" air quality day, where ozone pollution is expected to be low, but still high enough to affect certain sensitive groups such as children, the elderly, or people with preexisting lung problems such as asthma. Air quality action day alerts for Code Orange and higher are generally read on the radio or television during weather reports, but you can also sign up to receive them directly by visiting [RIDE Solutions](#).

Fortunately, there are some actions you can take to improve regional air quality. Reducing vehicle trips and, thus, vehicle emissions is one way to do this, so consider carpooling or biking to work during the week, if possible. Biking or walking to the store or to visit neighbors rather than driving is another way to reduce trips, as is trip chaining - planning your errands so as to take the smallest number of trips possible.

When air quality action days are forecast, there are some things you can do to help make sure we can avoid them. If you get gas, try to do so during the cooler parts of the day, since fumes from the gas pump are a significant and volatile precursor to ozone when mixed with a hot summer afternoon. Also, don't mow your lawn or use other small gas-powered machines, and the pollution control on these engines are very lax - in fact, many lawnmowers and other small engines pollute more than your average vehicle. Use an air quality action day as a reason to take a day off from yard work.

New Stormwater Management Regulations In Effect

Virginia's Stormwater Management Program (VSMP) Regulations became effective on July 1, 2014. New land disturbance projects submitted to the County for review after this date must meet the VSMP's more stringent design and calculation requirements, to include Part II A and Part II B. This includes providing a

Virginia's Municipal Separate Storm Sewer System (MS4) Permit Requirements

Storm Water Pollution Prevention Plan (SWPPP), runoff reduction water quality criteria and channel and flood protection water quantity standards. Allowable Best Management Practices (BMPs) to meet stormwater quantity and quality requirements are shown on Virginia's [Stormwater BMP Clearinghouse website](#). In

addition, the regulations require the County to assure that eligible projects have obtained coverage under the Construction General Permit, a task previously handled by the [Virginia Department of Environmental Quality \(DEQ\)](#).

In addition to the new state regulations, DEQ recently reissued the County's Municipal Separate Storm Sewer System (MS4) Permit, effective July 1, 2013. The MS4 Permit requires Roanoke County to operate its existing stormwater-related programs, along with some new ones, which include the aforementioned VSMP program, the existing Floodplain Management Program, the existing Erosion and Sediment Control program, and the new Total Maximum Daily Loads (TMDLs) program. To meet the new requirements, it is expected that businesses, in particular, may have to change some work practices, as follows:

- Car washing and dumpster rinsing may need to be modified to ensure TMDL pollutants (i.e., bacteria, sediment) are not being washed into the street or into the County's MS4.
- No wastewater from a business may be discharged to a storm drain.
- Employees may need training on Pollution Prevention and Good Housekeeping. Topics may include: (1) Spill prevention and response; (2) Proper disposal of wastes; (3) No wastewater discharge to the MS4; (4) Best Management

Practices, such as filtering discharges from construction and maintenance activities.

Want to Avoid Pain at the Pump this Summer?

As people pile into their cars for vacation, ready to take advantage of sunshine and summer breaks, gas prices across the country begin to skyrocket. Plantation Road Project Update

June 24th Board of Supervisors Work Session

County Staff updated the Board of Supervisors on the progress of the Plantation Road Project. Topics reviewed included the January 30th Citizen Information Meeting, changes to the proposed sidewalks and shared use paths, phasing, related future projects, potential funding sources for the future projects and alternative design scenarios. It was the consensus of the Board to continue with the original project scope and to continue to seek funding for related future projects.

Williamson Road and Plantation Road Intersection Pedestrian Signals Complete

Virginia Department of Transportation Revenue Sharing Program funds were awarded in Fiscal Year 2011 to construct pedestrian signals at the intersection of Williamson Road and Plantation Road. The signalization project began in May and was completed in August. The intersection now features four, push-button, count-down signals and crosswalks.

Project Phasing

The project has been broken into construction phases with the first phase including a shared use path from Williamson Road to Walrond Drive (west side), sidewalks from Walrond Drive to Gander Way (west side), sidewalks from Williamson Road to Friendship Lane (east side) with curb, gutter, street trees and pedestrian lights alongside the sidewalks and shared use path. Phase One will be advertised for construction in October, 2015, with construction anticipated to begin in early 2016.

Additional funding is needed to construct the remaining improvements. It is anticipated that Roanoke County will apply for Regional Surface Transportation Program (RSTP) funding for these improvements (see below for additional information.)

September 26th Regional Surface Transportation Program Application Deadline

Roanoke County anticipates applying for Regional Surface Transportation Program (RSTP) funding for the following Plantation Road projects:

- Lila Drive traffic signal including pedestrian signals, crosswalks, entrance relocations and reconstruction of a portion of Lila Drive;
- Reconstruction of Friendship Lane with bicycle and pedestrian accommodations;
- Replacement of the Friendship Lane/Carvin's Creek bridge; and
- Remaining Plantation Road Project improvements to include sidewalks, curb and gutter, street trees and pedestrian lights to Days Inn and McDonald's; side street bicycle and pedestrian accommodations and pedestrian signals at the Friendship Lane/Gander Way/Plantation Road intersection.

The RSTP funding source requires no local match. Awards will be announced next Spring.

Roanoke County also intends to apply for MAP-21 Transportation Alternatives Program funds by November 1st. This program requires a 20 percent local match and awards will also be announced next Spring.

Fall Design Public Hearing

The Design Public Hearing for the project will be scheduled for late October or early November. This meeting will be similar to the Citizen Information Meeting held in January, 2014, and will include 60 percent plans for the project. More details will follow soon.

West Main Street Sidewalk Construction Underway in Glenvar

Virginia Department of Transportation contractors are constructing sidewalks on a portion of West Main Street. As part of the [Route 11/460 Widening Project](#), the new sidewalk along the north side of the highway will connect to existing sidewalk in the [City of Salem](#), near [Fort Lewis Elementary School](#). The new sidewalk will continue past [Richfield Retirement Community](#), and end at Daugherty Road, in front of the new [Glenvar Library](#).

As originally designed, the 11/460 Widening Project did not include sidewalks. However, the project did include curb ramps at intersections, and right of way space behind the curb for sidewalks. Funds from the Regional Surface Transportation Program (RSTP) supported the addition of the new sidewalk. Virginia Department of Transportation engineers designed the new sidewalk, and added the construction to the existing project.

Roanoke County plans to seek additional RSTP funds to continue the sidewalk construction. Additional sidewalk would extend along the north side, from Daugherty Road to Fort Lewis Church Road, and along the south side from Salem to Technology Drive. Pedestrian signals would be added to existing signalized intersections.

Get Started with Carpooling

Anyone who thinks back to their earliest science classes will recall the astounding fact that most matter is empty space, because the atoms that form everything in the universe are themselves mostly empty - comprised of a few particles in their nucleus, some electrons zipping in orbit around that nucleus, and that's pretty much it. Various forces hold atoms together and to each other, but between those nuclei and electron orbits is nothing but space.

Now, imagine a tractor-trailer accident on I-81 causing a 5-mile traffic jam. Flying over the scene in a helicopter, you'd see a solid ocean of idling cars and trucks, bumper to bumper from exit 143 in Roanoke all the way past Salem filling two travel lanes. In fact, you'd be looking at over 7,000 cars taking up 20% of the interstate between Roanoke and Christiansburg.

And you'd mostly be looking at empty space.

In Roanoke, the vast majority of commuters drive alone. Each driver - the nucleus of the car, if you will - is only taking up 1/4 of total seat capacity at best, even less in the case of large SUVs or

minivans. If you look at that same traffic jam in terms of people rather than cars, a backup that might take hours to clear and fills a fifth of the interstate, actually involves so few people they could all fit in the Roanoke Civic Center with plenty of room to spare.

All those empty seats present an enormous opportunity to improve the capacity, efficiency, and lifespan of our roads, and can be realized without investing in any new technologies or transportation systems. In fact, the best, easiest solution is an old-fashioned one: carpooling.

Through [RIDE Solutions](#) regional carpool matching database, commuters have access to a free, simple way to find others who share their work hours and basic route. Commuters simply provide a few pieces of information about their commute through the website, and RIDE Solutions does the work of finding likely matches - including using regional park-and-rides and other meeting points to find potential carpool partners through a process called "corridor matching." Employees control how their data is shared with others, and there's no requirement to form a carpool with anyone on a given match list. Plus, their Guaranteed Ride Home program ensures that commuters are never stuck without a ride if something unexpected happens.

Though anyone can access the carpool matching system at [ridesolutions.org](#), employers contribute significantly to the success of the program. Employees are more likely to take advantage of carpooling if supported by their bosses and HR departments, and businesses can implement simple incentives such as preferred parking spaces and parking buy out that can be a win-win for your employees and your organization.

Energy Awareness Month is an Opportunity to Reduce Transportation Energy

October is National Energy Awareness Month, an opportunity for Roanoke County citizens to learn more about their own energy use, the impacts of energy use locally and globally, and small steps they can make to change their habits and reduce their consumption. [RIDE Solutions](#), the region's commuter alternatives program, wants to take this opportunity to remind all drivers in central and southwest Virginia that taking advantage of transportation options is not only a way to save money, it's also an important way to reduce energy consumption and our impact on the environment.

"Gas prices are volatile, constantly changing with the season and market. The energy impacts of fuel consumption are not," says Program Director Jeremy Holmes. "According to the Energy Information Administration, burning a gallon of petroleum produces 80 pounds of hydrocarbons, 606 pounds of carbon monoxide, and 41 pounds of nitrous oxides - all of which contribute to air pollution levels than can do everything from trigger asthma attacks to obscure the view of our beautiful mountains."

The Roanoke Valley, which has been slowly improving from borderline non-attainment for air quality in 2001, credits about half of the pollution that contributes to poor air quality from transportation-related sources generated within the valley.

Advancements in hybrid-electric and electric vehicles, along with improvements in fuel efficiency, have greatly reduced the energy intensity of automobiles, but there's more to the energy picture than what fuels the car. Things like road and parking infrastructure, land use, and green space are all affected by transportation choice. We're even learning more about how water quality can be affected by stormwater runoff that carries oil, gas, and other pollutants from our roads and parking lots into our water supply.

What is an Inoperative Vehicle?

An inoperative motor vehicle, trailer or semitrailer is defined as: "any motor vehicle, trailer or semitrailer which is not in operating condition, or which for a period of sixty (60) days or longer has been partially or totally disassembled by the removal of tires and wheels, the engine or other essential parts required for operation of the vehicle or on which there are displayed neither valid license plates nor a valid inspection decal."



It is unlawful to keep on any property any inoperative motor vehicle, trailer or semitrailer, unless the vehicle is completely screened or shielded from public view or fully enclosed within a building or structure.
