The Board of Supervisors held public hearings and approved:

- The [petition](#) of Fellowship Community Church to rezone property to remove the proffered conditions and to obtain a special use permit for a religious assembly on approximately 3.50 acres zoned C-2C, High Intensity Commercial, District with conditions, located near the 6500 block of Merriman Road, Cave Spring Magisterial District.
- The [petition](#) of David and Stace Todd to obtain a special use permit in a R-1, Low Density Residential, District to comply with the use and design standards associated with an accessory apartment in an accessory building on approximately 0.346 acre, located at 1047 Barrens Village Court, Hollins Magisterial District.

Pending more information, the Board of Supervisors delayed a decision on a [petition](#) by the Roanoke Valley Resource Authority for a special use permit for a sanitary landfill on approximately 8.05 acres and to amend the special use permit for an existing sanitary landfill located on the northwest side of Fort Lewis Mountain between Smith Gap, and Bradshaw Road.

The petition was postponed at the request of the petitioner.

Summertime Zoning Tips



Here are a few seasonal reminders from our zoning code enforcement team:

- Grass must be kept below 12 inches unless it is for an agricultural use in an agriculturally zoned area.
- All buildings must have a zoning permit before they are built or delivered no matter what size they are.
- Residential Chicken Keeping requires a permit before the chickens can be brought to the house.

The Planning Commission held a public hearing for [Milestone Tower Limited Partnership's request](#) to rezone 9.55 acres (Stonebridge Park) from R-1, Low Density Residential District to AR, Agricultural/Residential District, and to obtain a special use permit for a broadcasting tower (cell tower) approximately 137 feet in height located at 420 Swan Drive (Stonebridge Park), Vinton Magisterial District. The Commission recommended approval of the petition.

The Planning Commission held a public hearing at 7:00 p.m. for the [petition of Appalachian Power Company](#) and the Roanoke County

Economic Development Authority to review a proposed substation and overhead transmission lines per Section 15.2-2232 of the Code of Virginia for consistency with the County's Comprehensive Plan, located within the Roanoke County Center for Research and Technology at 5495 Corporate Circle, Catawba Magisterial District. The Commission recommended approval of the petition.

16th**

The Planning Commission held a work session on zoning ordinance amendments to include home beauty/barber salon, short term rentals, temporary construction yards, and yard encroachments.

**Nov.
17th**

The Board of Supervisors held a public hearing for Milestone Tower Limited Partnership's request for a rezoning and special use permit. The Board denied the request.

The Board of Supervisors held a public hearing on AEP's and the EDA's petition to review a proposed substation and transmission lines. The Board accepted the Planning Commission's recommendation that the proposed project was consistent with the County's Comprehensive Plan.

30th**

The Planning Commission held a public hearing for the petition of Michael H. Fielder to rezone approximately 8.73 acres from AG-1, Agricultural/Rural Low Density District to I-1, Low Intensity Industrial District, located at 4053 Aerospace Road, Vinton Magisterial District. The Planning Commission voted to recommend approval of the rezoning request. The Board of Supervisors will hold a public hearing on this request at its December 15th meeting.

The Planning Commission will hold a work session on potential zoning ordinance amendments.




New Greenways Website

Roanoke Valley Greenways has just launched a sleek new website with trail pages and interactive maps! In 2019, the AEP Foundation awarded \$30,000 to “power” the redesign effort in order to attract new users to regional greenways and help longtime users discover new routes and trailheads. The new site features important information about the greenway network like route characteristics, parking and amenities, as well as news about events, volunteer opportunities and closures. The website also allows users to search for trails by particular uses, like hiking, cycling, wheelchairs, dog walking or even bird watching, so every visitor can find the experience they want. Plantation Road & Lila Drive Intersection Improvements Complete

Lila Drive Intersection Safety Improvements were initiated in 2009 to enable employees at the three largest businesses on Plantation Road - ITT (now Elbit Systems of America), Wells Fargo and Double Envelope - to safely cross Plantation Road on foot. A 2014 analysis showed that a traffic signal could be installed at the intersection to reduce crashes and improve safety for turning vehicles. Roanoke County purchased the Lila Drive private road in 2015 and submitted an application for grant funding that year. \$1.27 million in SMART SCALE funds were awarded for the project in 2016. Construction that began in May, 2020 is now concluding.

The project includes:

- Traffic signal installation at the intersection of Lila Drive and Plantation Road;

- Pedestrian signals and crosswalks at the intersection;
- Double Envelope entrance realignment;
- Wells Fargo entrance consolidation on Lila Drive; and
- Sidewalk on the Wells Fargo side of Lila Drive.

The crosswalks connect to the Plantation Road shared use path, which runs between Williamson Road and Walrond Drive. Many thanks to the Virginia Department of Transportation for administering and completing this important County project.

The next phase of the Plantation Road project will begin in Spring 2021 with construction of a sidewalk between Walrond Drive and Gander Way, realignment of the Walrond Drive intersection and pedestrian signals at the Plantation Road/Gander Way traffic signal.
