The Roanoke River Greenway is an important regional project that will eventually run over 30 miles along the Roanoke River linking Montgomery County to Explore Park. As a part of this regional greenway, we are evaluating how best to route the greenway from the Western Virginia Water Authority Water Pollution Control Plant to the Blue Ridge Parkway. We would like to invite you to a community meeting to review and discuss preliminary greenway alignments that are being considered in your area.

2. Online: The survey will be available online at [www.RoanokeCountyVA.gov/ERRGap](http://www.RoanokeCountyVA.gov/ERRGap) on July 1<sup>st</sup> along with all of the materials shown at the community meeting; and
3. By mail: We will mail out the preliminary greenway alignment exhibit and a paper copy of the survey to you around June 30<sup>th</sup> and you can mail the survey back to us.


