 - b. Can a bidder select only certain areas to bid?
Bidders may submit a partially completed bid form, only bidding on selected locations. Roanoke County reserves the right to award one or more contracts, for all or some of the listed locations, as is in the best interest of the County.

ARTICLES OF AGREEMENT made this tenth (10th) day of August, 2017, by and between One Earth Landscape Management Company, Inc., 3317 Brandon Avenue, Roanoke VA 24018, also referred to as the Vendor, and Roanoke County, also referred to as the OWNER.




