The above Project is hereby changed as addressed below:

1. Extension of Due Date: Please note that the due date and time has hereby been extended to Monday, May 15. Bids are due to the Roanoke County Purchasing offices no later than 2:00 PM local time, on May 15, 2023.
2. Revised Bid Form: Please see attached as Exhibit 1 to this Addendum, a revised bid form to include unit pricing for fill. Bidders must submit a completed copy of this revised form in order to be successfully considered for award.
3. Clarifications to Project Specifications: The following clarifications are offered as a result of questions posed at the pre-bid conference held on May 4, 2023.
 - a. A metal handrail, to be installed on the steps of the porch, shall be included in the cost of the Base Bid.
 - b. The stone from the existing columns should be kept and reused.
 - c. Bushes may be trimmed to provide site access, with prior approval from Roanoke County.
 - d. The concrete of the existing porch should not be used as fill.
 - e. The location of the septic system will be provided to the successful bidder prior to the start of work.

Note: A signed acknowledgment of this addendum must be received at the location indicated on the original solicitation either prior to the proposal due date or attached to your proposal.
