Description: Box Truck for RCPS Nutrition

Issue Date: February 27, 2024

Bids Due: March 8, 2024

The above Project is hereby changed as addressed below:

1. Responses to Questions Submitted: Please see the following list of questions submitted by prospective Bidders, and the responses provided by RCPS as we are able.
 - a. Delivery required timeline?
Delivery as soon as possible. Bidders should indicate their earliest available delivery date, OR the time from order placement to delivery, on their submitted Bid Form.
 - b. Chassis:
 - i. Cab chassis or cutaway? *Cab.*
 - ii. SRW/DRW? *Dual Rear Wheel.*
 - iii. GVWR? *Below CDL ratings.*
 - c. Upfit:
 - i. Floor material? *Wood.*
 - ii. Wheel boxes or flat floor? *Flat floor; box should sit above wheel wells and chassis.*
 - iii. Roll up rear door? *Roll up.*
 - iv. B/U alarm? *Yes.*
 - v. Solid/Translucent roof? *Solid roof.*
 - vi. Lift gate:
 1. steel or aluminum platform? *Steel platform.*
 2. Tethered switch to operate? *Mounted switch.*
 - d. Spec line A.e. “engine: L8T-engine, gas, 8 Cyl, 6.6L” is a GM code indicating the chassis is to be an Express cutaway or equal. A cutaway from any manufacturer (Chevrolet, Ford, RAM) is not compatible with spec line A.c. “60”/2,000 lb. tuck away lift gate” because there simply isn’t enough space under the box. A 60” tuckaway liftgate is only compatible with a much larger truck such as an International or Freightliner. Would the County accept a 60” railgate? Or the largest possible platform tuckaway liftgate?

RCPS is not interested in a cutaway; this IFB specifies a box truck. The vehicle bid should be equivalent to the specifications hereby provided as Attachment A to this Addendum.

- e. Spec line A.a “Minimum 7’ tall opening in back” is a special-order specification. 16’ boxes typically have an overall height of 85” with the door rear door height being 79”. Would the County accept a five-inch shorter door opening if it meant expedited delivery?

Please reference Attachment A to this Addendum for a spec sheet including the specified required door height. If a Bidder submits a door height different than what is specified, this should be clearly indicated on their submission. The County will determine whether the vehicle bid meets the specifications as listed.

Note: A signed acknowledgment of this addendum must be received at the location indicated on the original solicitation either prior to the proposal due date or attached to your proposal. Signature on this addendum does not substitute for your signature on the original proposal/bid document. The original proposal/bid document must be signed.
