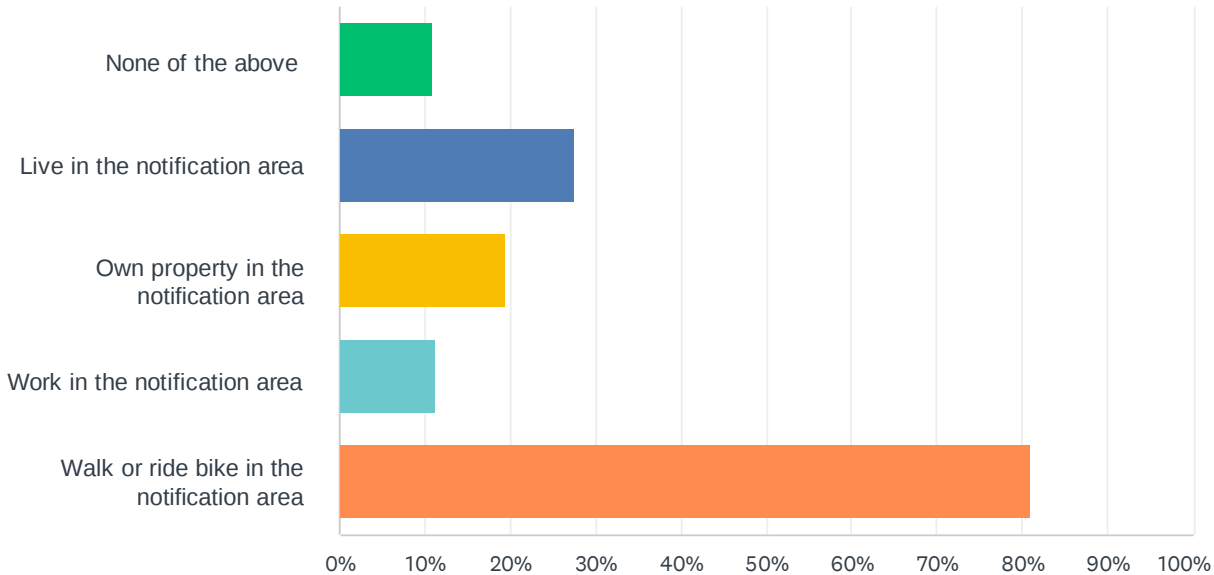
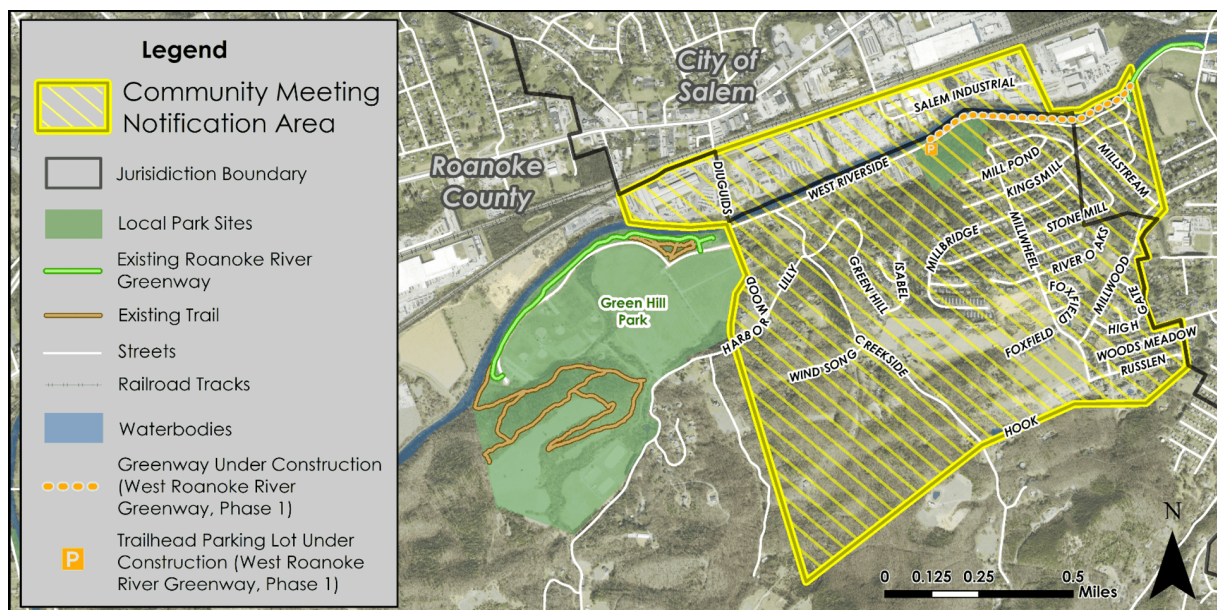


## What is your relationship to the community meeting notification area for this project, shown on the map below? (check all that apply)

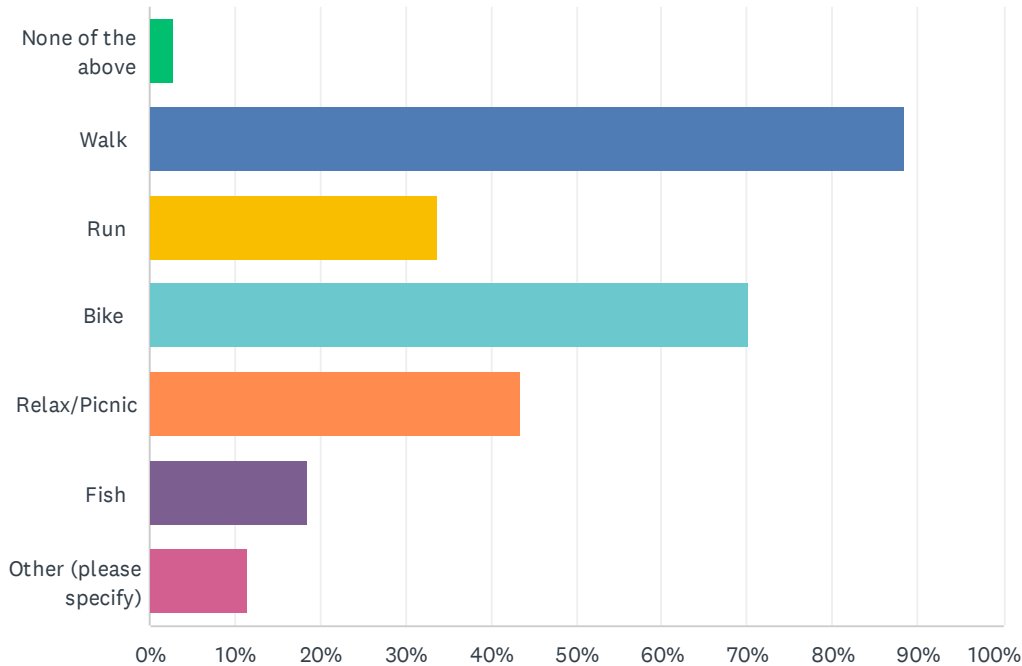

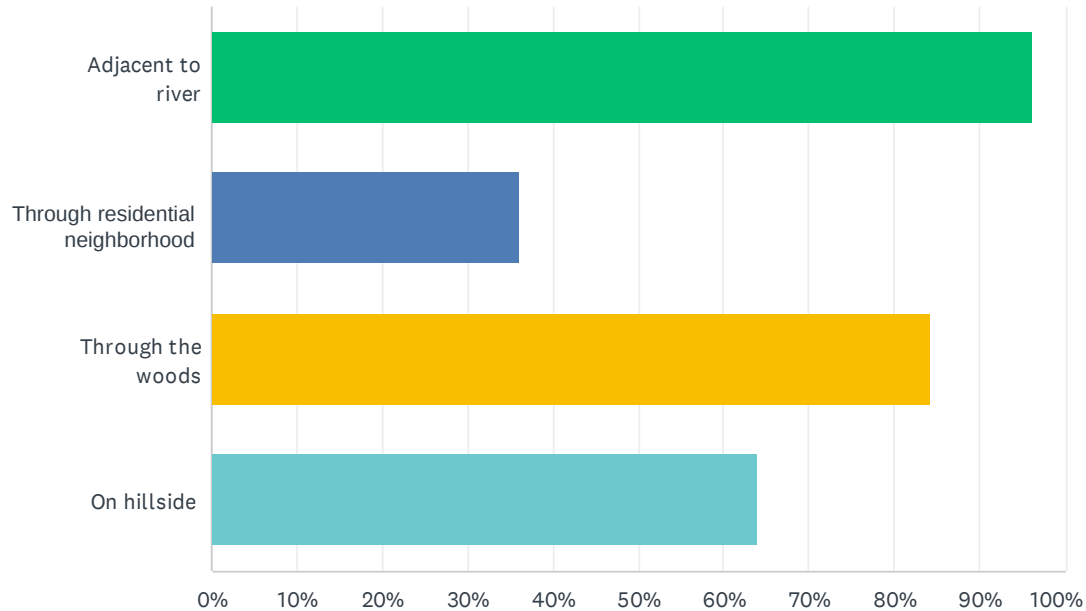

## What kind of greenway would you like to see in your community? (select as many as you like)

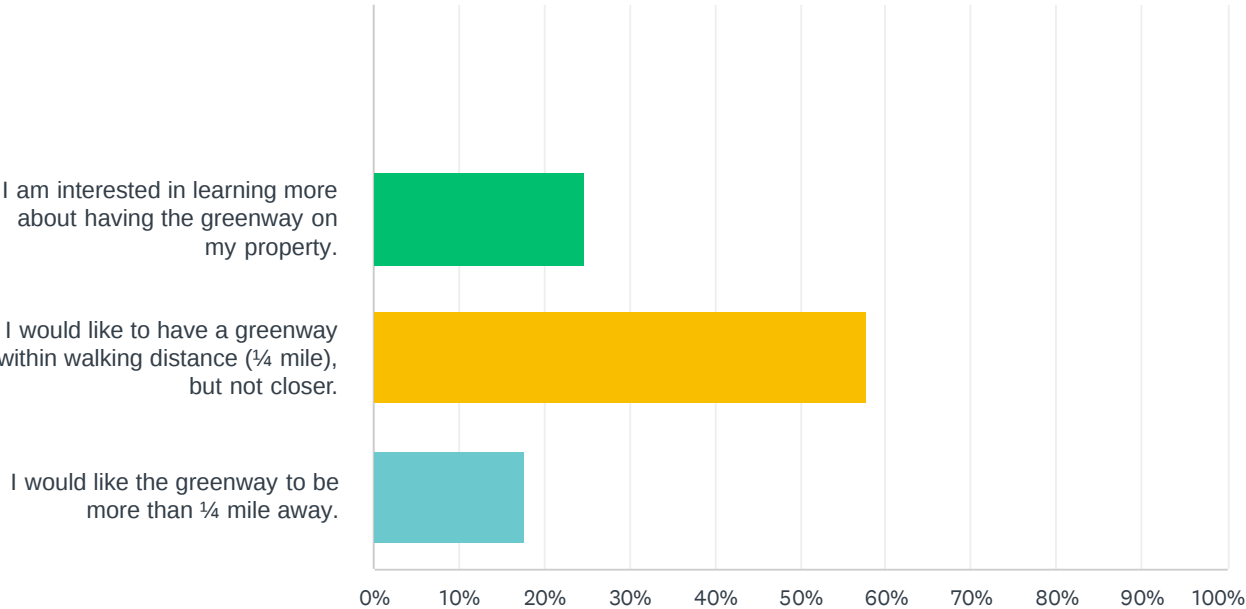
