6) Will this project have an itemized bid form or lump sum only?

This project is a lump sum project.

7) Will this project have potential milestones?

Substantial completion will be considered achieved when all required grading is finished, and site stabilization (seeding/matting/straw) has been installed. Due to the anticipated timeline for construction, installation of planted stock shall not be considered part of substantial completion and may be deferred to the nearest date within the specified planting window (e.g. fall/winter). The planting warranty shall begin upon completion of all plantings.

8) Question regarding Balanced or Importing Material??

The project has been designed to roughly balance when accounting for the anticipated import of required rock and reinforced bed material. It is expected that removal of limited quantities of unsuitable material (asphalt, concrete rubble, etc.) may be necessary. The contractor remains responsible for their own quantity take offs and associated bid. Any erosion or deposition happening since existing conditions survey was completed and its corresponding effect on excavation/import are the responsibility of the contractor and shall be accounted for in the bid.

9) What is the deadline for questions?

Questions are due Thursday October 10, 2024.

10) How long has the current rip rap been in place?

The County has no knowledge of when the rip rap was installed. It has been in place for longer than 12 years.

11) Is the upstream patio part of the easement?

It is within the easement.

DATA ON CONVICTIONS FOR CERTAIN CRIMES

Data and Convictions information will be requested before the County of Roanoke/Schools enters into a contract / when required.
