Additional Specifications

Chemical Supplies:

Industrial Kitchen Equipment must have chemical supplies dispenser that can be attached to the equipment. These dispensers must be monitored and adjusted for chemical accuracy.

Chemical dispensers may include soaps, rinse agents and sanitizers.

Equipment requiring dispensers may include sinks, dishwashers or other items deemed necessary for the operation of the kitchen.

A mechanism (call center) for making service calls when there are maintenance issues that require adjustments and/or repairs.

The estimated time of service must be within a 24-48 hour period.

A mechanism for ordering product, online ordering is required. The site manager will be responsible for ordering product. Vendor must provide support to management staff on SDS sheets and product specifications.

Dishwashers are high and low temperature

Sinks use liquid sanitizer (Quaternary Ammonium)
